

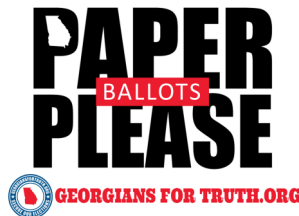

## Local Authority Election Act

The Local Authority Election Act governs community government elections in Alberta, Canada. This legislation establishes procedures for:

- Eligibility criteria for voters and candidates
- Election calendar and process
- Recounts and judicial reviews
- Unlawful election activities
- Disposal of used voting materials

### Key Provisions

1. **Election Officials:** Local governments must appoint a Chief Election Officer and a Deputy Chief Election Officer to conduct elections.
2. **Voter Registration:** Local governments may maintain an ongoing register of resident electors or use the most current available Provincial list of voters prepared under the Election Act.
